world without pollinators? Unthinkable! An estimated three guarters of leading global food crops rely on animals for pollination¹, including bees, beetles, moths, butterflies, birds and bats. Managed European honeybees are essential pollinators in America's intensely agricultural areas, however, declines related to Colony Collapse Disorder have led researchers to look at *native* pollinators in new ways. "There are thousands of species of native, wild pollinators, and in agricultural landscapes where their habitat needs are met, they are sufficient to pollinate crops," says Rutgers Assistant Professor Rachael Winfree. sting? "Recent work from our lab showed that native pollinators alone fully pollinate over 90% of the watermelon farms in New Jersey and Pennsylvania." Most wild pollinators nest individually in the ground or in twigs and need undisturbed, pesticide-free areas in which to do so¹.


